## Portfolio Name

Transamerica Vanguard ETF Portfolio – Balanced VP\*

## Objective

This investment option invests in a portfolio which seeks to balance capital appreciation and income.

## Strategy

This investment option invests in a portfolio which seeks to achieve its objective by investing its assets in a combination of underlying exchange traded funds (“ETFs”). Investment strategies include:

- The portfolio expects to allocate substantially all of its assets among underlying ETFs that track the performance of a benchmark index to achieve targeted exposure to domestic equities, international equities and domestic bonds. The portfolio intends to achieve a mix over time of approximately 50% of portfolio assets in ETFs that invest primarily in equities and 50% of portfolio assets in ETFs that invest primarily in U.S. fixed income securities. These percentages may vary.
- The portfolio’s manager decides how much of the portfolio’s assets to allocate to each underlying ETF based on what it considers to be prudent diversification principles and historical performance.
- The manager may periodically adjust the portfolio’s allocations to favor investments in those underlying ETFs that are expected to provide the most favorable outlook for achieving its investment objective.

## Underlying ETFs

ETFs—a collection of stocks similar to mutual funds that trade like stocks on major exchanges—seek to track a benchmark, are typically relatively inexpensive, and offer a wide range of investment choices. ## What is a Variable Annuity?

## Fees

Transamerica variable annuities' range of fees and charges include 0.45%–1.90% M&E&A, 0%–9% surrender charges, \$50 annual service charge, and investment option management fees. A fund facilitation fee of up to 0.30% annually may apply for certain investment options.
