Investment Strategy

This investment option invests in a portfolio whose sub-adviser, Aegon USA Investment Management, LLC (AUIM), seeks to achieve the portfolio's objective by investing its assets primarily in a combination of underlying exchange traded funds (ETFs). Under normal circumstances, AUIM expects to allocate substantially all of the portfolio's assets among underlying ETFs to achieve targeted exposure to domestic equities, international equities and domestic bonds.
